Pursuant to the inspection report (Ref.3) compliance report, undertaking submitted and fund remitted by the college (3,4,&5) approval of the Ministry of Health & Family Welfare(Ref.6) approval of the University is hereby accorded for extension of provisional affiliation for B.A.M.S. course with 50 seats intake [fifty only] in Rajiv Gandhi Ayurveda Medical College & Hospital, Mahe for the academic year 2013-14, subject to the condition that all the deficiencies observed and communicated by the University vide letter dt.19.07.13 and by the Department of Ayush, Ministry of Health & Family Welfare, Govt. of India (ref.6) are rectified and the compliance report with supporting documents are submitted by 31st December 2013 for verification of the same, failing which extension of provisional affiliation for next academic year i.e 2014-15 will not be considered.

The Administration of the institution shall discharge the statutory duties relating to pension, gratuity, provident fund etc. for its employees.

Surprise checks may be conducted to ensure that all compliances reported have been actually taken care.

In case of violation of any of the conditions of the University, the affiliation would be withdrawn and the college alone would be responsible for all consequences in this regard. In such an event, the affiliation fund would stand forfeited to the University.

This provisional affiliation shall be valid only for a period of one academic year i.e., 2013-2014 and the request for renewal for the academic year 2013-14 should reach before 7th January 2014.

Admission for the next academic year i.e, 2014-15 should not be made / done without the approval of the Ministry of Health & Family Welfare ,Govt. of India and valid affiliation of the University.
