I am to communicate the following observations of the Inspection committee which had visited your institution on 27.06.14 in connection with your request for extension of provisional affiliation for B.A.M.S. course with an intake of 50 seats [Fifty only] for the academic year 2014-15

1. *Completion/construction of the new building as recommended by the previous affiliation team for housing hospital, hostels and staff quarters is to be taken up in phase wise. However the College must submit its proposed report plan of achieving the target immediately and newly ongoing construction work for classrooms/lab to be completed within one month as promised by the Principal*
2. *Permanent librarian and Physical Education Director are to be recruited at the earliest by following University procedure*
3. *Practical halls are to be more spacious*
4. *Periodicals/journal to be increased substantially*
5. *Complaints/Grievances of the students regarding food, water toilet facilities for girls staying in rented houses hostels to be rectified immediately and compliance report must be submitted to the University within a month*
6. *Hostel facilities for boys required to be taken up immediately*

7. *Councilor to be appointed/hired basis*
8. *Library with computer facilities & computer lab is must*
9. *CPF contribution is still deposited in S.B. Account which must be stopped*
10. *Computer facility is fulfilled only to certain extent but recommended number of 20 computers by the previous inspection committee 2013-14] is yet to be fulfilled*
11. *Sports facilities is not sufficient and the college should give due importance to improve sports and provide facilities*
12. *Canteen facilities , facilities for differently abled person , Transport , Book Bank , Bank extension counter are not available and should be looked into and improvement is necessary*
13. *Financial resource/budget allocation of the College is not sufficient*

You are required to rectify /comply with the above deficiencies and submit the compliance report with proof/supporting documents at the earliest.

After submission of compliance report for the above requirements along with proof you would be required to (i) remit ₹.75,000/-[Rupees seventy five thousand only] towards affiliation fund and (ii) submit an undertaking on non judicial stamp paper, executed by the authorized signatory of the College signed before Notary Public towards fulfillment of affiliation conditions as per Annexure to this letter .

Admission of students should not be made without valid affiliation of Pondicherry University
