Pursuant to the Conditional Permission issued by the Ministry of Ayurveda, Yoga & Naturopathy, Unani, Siddha and Homeopathy (AYUSH) (Ref.1), affiliation fund remitted and Undertaking submitted (Ref.4), the approval of the University is hereby conveyed for the extension of provisional affiliation for **B.A.M.S course – with an annual intake of 50 seats** (fifty only) in Rajiv Gandhi Ayurveda Medical College & Hospital, Mahe for the academic year 2015-16, subject to approval of the Academic and Executive Councils of the University.

The College should fulfill all the affiliation conditions as stipulated in our letter dated 20.11.2015 and fulfill the conditions specified by the Ministry of Ayurveda, Yoga & Naturopathy, Unani, Siddha and Homeopathy (AYUSH), Govt. of India, New Delhi.

All faculty positions should be filled up without existence of any vacant position as per UGC/CCIM norms and the appointments should be made on permanent and full time basis in the presence of University Nominee.

All changes in the teaching staff and other changes that may affect the fulfillment of the conditions for affiliation should be reported to the University within a fortnight.

Request for University nominee for appointment of faculty shall be sent to the University at least one month in advance.

The Advisory Committee meeting should be conducted at regular intervals as per

The Management of the college shall discharge the statutory duties relating to pension, gratuity, provident fund, etc., for its employees.

Surprise checks will be conducted by the University, to ensure that whether all compliances reported have been actually taken care of.

In case of violation of any of the conditions of the University, the affiliation would be withdrawn and the college alone would be responsible for all consequences in this regard. In such an event, the affiliation fund would stand forfeited to the University.

This provisional affiliation shall be valid only for a period of one academic year i.e. 2015-16. Admission of students for the next academic year i.e. 2016-17 should not be made/done without approval of the Ministry of Ayurveda, Yoga & Naturopathy, Unani, Siddha and Homeopathy (AYUSH), Govt. of India, New Delhi, and valid affiliation from the University.
