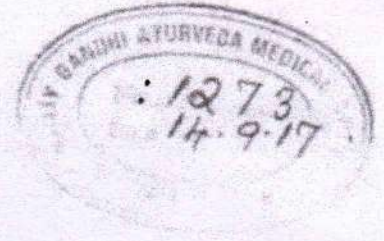

Pursuant to the inspection report dated 06.03.2017 (Ref.3), funds remitted and undertaking submitted (Ref.6) and compliance verification report (Ref.7) approval of the University is hereby accorded for the **conditional continuation of provisional affiliation** to the existing UG course in Rajiv Gandhi Ayurveda Medical College & Hospital, Mahe for the academic year 2017-18 **subject to increase of space for OP Department and ratification by AC/EC of the University:**

The College should fulfill all the affiliation conditions as stipulated in our letter dated 10.04.2017.

The observations made by the Inspection Committee that have been agreed to be implemented and as undertaken by the College vide your letter dated 08.05.2017 should be complied.

The College should fulfill all the conditions stipulated by AYUSH in letter No.R-12011/02/2010-EP(IM-1) for 2016-17, dated 13.10.2016.

All faculty positions should be filled up without existence of any vacant positions as per UGC/AYUSH norms and the appointments should be made on permanent and full time basis in the presence of University nominee.

The Selection Committee minutes of all appointments should be sent to the University along with the list of faculty for approval.

All changes in the teaching staff and other changes that may affect the fulfillment of the conditions for affiliation should be reported to the University within a fortnight.

Request for University nominee for appointment of faculty shall be sent to the University atleast one month in advance.

The Advisory Committee meeting should be conducted at regular intervals as per norms with University nominee in the Advisory Committee and minutes submitted to the University.

The College shall strictly follow the UGC Guidelines/Regulations 2009 on curbing the menace of ragging in Higher Educational Institutions (Under Section 26 (f) (g) of the University Grants Commission Act 1956).

The **Sexual Harassment Prevention Committee** should be constituted as per UGC regulations 2015.

Insurance, Fire Service NOC, Groundwater user license and PPA permit should be renewed periodically.

The Management of the institution shall discharge the statutory duties relating to pension, gratuity, provident fund etc., for its employees.

Admission of students and collection of fee should be made strictly in accordance with GOI/GOP/University norms. The University calendar should be followed without any deviation.

Excess admission of students over and above the approved intake in respect of any course will not be entertained by the University under any circumstances.

Admission of students should not be made to the courses for which there is no affiliation.


Surprise checks will be conducted to ensure whether all the compliances reported have been actually taken care of. In case of violation of any of the conditions of the University, the affiliation would be withdrawn and the college alone would be responsible for all consequences in this regard. In such an event, the affiliation fund would stand forfeited to the University.

This conditional provisional affiliation shall be valid only for a period of one academic year i.e. 2017-18. Application for affiliation of new course(s)/seat increase, if any, for the academic year 2018-19 should reach the Registrar, Pondicherry University on or before 1st October 2017 and the request for renewal of affiliation for the academic year 2018-19 should reach before 7th January 2018.

Admission of students for the next academic year i.e. 2018-19 should not be made/done without the approval of the AYUSH and valid affiliation from the University.
