Pursuant to the Inspection Report (Ref.2), funds remitted, Compliance Report and Undertaking submitted by the College (Ref.4,7&9), approval of Ministry of AYUSH, New Delhi(Ref.5) and Compliance Verification Report (Ref.6), approval is hereby accorded for continuation of provisional affiliation for the existing UG course with increase in intake of students as detailed below in Rajiv Gandhi Ayurveda Medical College & Hospital, Mahe for the academic year 2019-20, subject to fulfillment of affiliation conditions and also subject to ratification by AC/EC of the University:-

**Continuation of Provisional Affiliation for the year 2019-20**

The College should fulfill all the affiliation conditions as stipulated in our letter dated 22.5.2019 and fulfill the conditions in terms of Infrastructure/Faculty requirement/other conditions for the increased intake as specified by the Ministry of AYUSH from time to time.

The observations made by the Inspection Committee that have been agreed to be implemented as undertaken by the College in your Undertaking dated 3.6.2019 should be complied.

All faculty positions should be filled up without existence of any vacant positions as per UGC/AYUSH norms and the appointments should be made on permanent and full time basis by duly constituted Selection Committee with the University nominee.

The Selection Committee minutes of all appointments should be sent to the University along with the list of faculty for approval.

All changes in the teaching staff and other changes that may affect the fulfillment of the conditions for affiliation should be reported to the University within a fortnight.

Request for University nominee for appointment of faculty shall be sent to the University atleast one month in advance.

The Governing Body meeting should be conducted at regular intervals as per norms with University nominee in the Governing Body and minutes submitted to the University.

The College shall strictly follow the UGC Guidelines/Regulations 2009 on curbing the menace of ragging in Higher Educational Institutions (Under Section 26 (I) (g) of the University Grants Commission Act 1956).

**The Sexual Harassment Prevention Committee** should be constituted as per UGC regulations 2015.

**Insurance, Fire Service NOC, Groundwater user license and PPA permit should be renewed periodically.**

**The College should take pro-active measures for rain water harvesting and recharging ground level water as per the minutes communicated vide letter dated 24.07.2018.**

The Management of the institution shall discharge the statutory duties relating to pension, gratuity, provident fund etc., for its employees.

Admission of students and collection of fee should be made strictly in accordance with GOI/GOP/University norms. The University calendar should be followed without any deviation.

Excess admission of students over and above the approved intake in respect of any course will not be entertained by the University under any circumstances.

Admission of students should not be made to the courses for which there is no affiliation.

Surprise checks will be conducted to ensure whether all the compliances reported have been actually taken care of. In case of violation of any of the conditions of the University, the affiliation would be withdrawn and the college alone would be responsible for all consequences in this regard. In such an event, the affiliation fund would stand forfeited to the University.

**This provisional affiliation shall be valid only for a period of one academic year i.e. 2019-20. The request for renewal of affiliation for the academic year 2020-21 should reach on or before 7<sup>th</sup> January 2020.**

**Admission of students for the next academic year i.e. 2020-21 should not be made without the approval of the Ministry of AYUSH and valid affiliation from the University.**
