



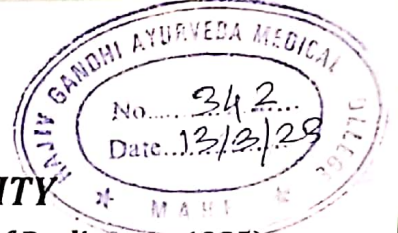

Pursuant to the Inspection Report (Ref.2), funds remitted, Compliance Report and Undertaking submitted by the College (Ref.4) and Compliance Verification Report (Ref.5), approval of the University is hereby accorded for the **Conditional Provisional Affiliation** for the existing UG Course as detailed below in **Rajiv Gandhi Ayurveda Medical College & Hospital, Mahe** for the academic year 2022-23, subject to ratification by AC/EC of the University:

The College is directed to abide by the following conditions:

1. Conditional Affiliation for all courses for the Academic year 2022-23 as the NCISM has accorded only Conditional approval. Further the college yet to appoint Regular Principal, Senior faculty members as per Inspection Committee recommendations.
2. The observations made by the Inspection Committee that have been agreed to be implemented vide Undertaking 4<sup>th</sup> cited should be complied with. All Affiliation Conditions of Pondicherry University with respect to admissions, faculty recruitment, fee collection from students, conduct of Exams, etc., should strictly be adhered to by the College.
3. Colleges offering such courses which require the approval of Statutory Bodies like NMC/AYUSH etc, should not conduct admissions until their clearance.
4. All necessary measures required for post – COVID-19 sanitization, students health care, etc., should strictly be adopted.
5. All Govt. of India schemes should be implemented and necessary students activities for Nation Building should be carried out.
6. The UGC directions in controlling Ragging in campuses, Drug abuse, Sexual Harassment shall be strictly adopted.
7. The University reserves the right to utilize all the information submitted by Colleges relating to faculty profiles, etc., for answering all RTI queries, legal requirements, CBI enquiries, etc.
8. The Governing Body Meetings should be organized regularly. Compliances to different GOI Organisations like ESI, PF, Gratuity, GST, Income Tax authorities should be made and a copy of audited Annual Accounts should be submitted to the University.
9. Insurance, Fire Service NOC, Groundwater user license and PPA permit should be renewed periodically.
10. The College should take pro-active measures for rain water harvesting and recharging ground level water as per the Minutes communicated vide letter dated 24.07.2018.
11. Surprise checks will be conducted to ensure whether all the compliances reported have been actually taken care of. In case of violation of any of the conditions of the University, the affiliation would be withdrawn and the college alone would be responsible for all consequences in this regard. In such an event, the affiliation fund would stand forfeited to the University.

12 The jurisdiction in respect of any dispute against Pondicherry University relating to affiliation shall be at Madras High Court only.

13. This provisional affiliation shall be valid only for a period of one academic year i.e. 2022-23.
